

## Call for Proposals for:

# The **IMPACT** Program (**IP** Management Program for Academic Institutions Commercializing Technologies)

The Philippine Council for Industry, Energy and Emerging Technology Research and Development (PCIEERD) is announcing its new program for researchers interested in commercializing technologies through an invitation to the **1<sup>st</sup> Call for Proposals for the PCIEERD IMPACT Program**. The program is established to capacitate and assist universities in setting up their technology transfer processes and facilitate commercialization of university-owned technologies. The fund assistance being requested should aim to:

1. To establish processes and policies on technology commercialization in universities
2. To jumpstart the commercialization of university owned technologies through protection, assessment and audit
3. To provide the tools and manpower resources for the conduct of full market assessments of technologies (minimum of 6 tech)
4. To support the promotion of university-owned technologies
5. To generate at least two license agreements on PCIEERD-funded technologies

This call for proposal is open to Universities with substantial PCIEERD-funded Technologies or PCIEERD investment in R&D. Interested universities may avail of any of the following funding tracks:

- **IP Track 1: Institutional Assistance for Commercializing Technologies**

Scope: Establishment of IP management or tech transfer processes, technology audit, technology roadmapping, IP disclosure generation, technology promotion, industry consultations, capability building, negotiation and licensing

Metrics/Output: processes established, technologies audited, technologies assessed, invention disclosures, IPs protected, licensed technologies

- **IP Track 2: Bulk Assessment prior to commercialization**

Scope: Market assessment for technologies in a program (minimum of 5 technologies)

Metrics/ Output: individual assessments or recommendations for technologies, Go or No Go decision for each technologies

The qualifications of Universities who can avail of the fund assistance are:

- Must be a university with PCIEERD funded technologies (minimum of 10 technologies)
- Must have significant PCIEERD GIA investment

Special requirement:

Commitment from the University to sustain the technology management office and tech transfer processes

All interested Universities may submit their Capsule Proposal to the Philippine Council for Industry, Energy and Emerging Technology Research and Development (PCIEERD) thru the Research Information and Technology Transfer Division (RITTD).
