**The Department of Science and Technology-Executive Committee (DOST-EXECOM) Resolution
for the Approval of Funding of the DOST-Grants-In-Aid (GIA) Programs/Projects Amounting to
P5M and Below**

RESOLUTION NO. 2018-2

WHEREAS, Section VII.3.c "Project Proposal Flow/Approval/Release of Funds" under the Revised DOST-GIA Guidelines (Administrative Order No. 009 Series of 2017), stipulates that "All new projects to be funded under the DOST-GIA Program shall be subject to approval of the EXECOM except for projects amounting to five million pesos (P5,000,000.00) and below which may be approved by the Undersecretary for Research and Development (R&D)".

WHEREAS, the project proposal shall be evaluated through an established project review mechanism and will be endorsed by the appropriate Sectoral Council/DOST agency to monitor the project namely, National Research Council of the Philippines (NRCP), Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD), Philippine Council for Health Research and Development (PCHRD), and Philippine Council for Industry, Energy and Emerging Technology Research and Development (PCIEERD) and shall be required for all project proposals.

WHEREAS, in its meeting held on 21 June 2018, the DOST-EXECOM discussed the procedure regarding the approval process of DOST-GIA programs/projects amounting to P5M and below:

WHEREAS, the DOST-EXECOM agreed that evaluation for said programs/projects will be conducted by the in-house evaluators, namely: a) NRCP Concerned Division Chair/Technical Expert; b) PCAARRD Directors' Council; c) PCHRD In-House Review Committee; and d) PCIEERD Management Team.

WHEREAS, in accordance with the abovementioned procedure under the Revised DOST-GIA Guidelines, said projects will be approved by the Undersecretary for Research and Development after the conduct of evaluation by the in-house evaluators;

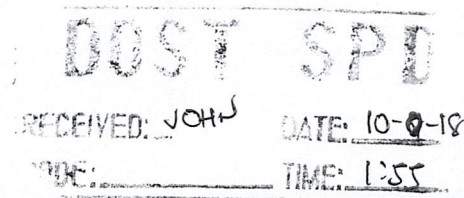
NOW, THEREFORE, We the Members of the **DOST-EXECOM, RESOLVE** as it is hereby **RESOLVED**, to adopt the agreed amended evaluation process for DOST-GIA programs/projects as follows:

1. Evaluation of DOST-GIA programs/projects amounting to P5 Million and below will be conducted by the applicable in-house evaluators, namely: a) NRCP Concerned Division Chair/Technical Expert; b) PCAARRD Directors' Council; c) PCHRD In-House Review Committee; and d) PCIEERD Management Team;
2. Thereafter, the program/project shall be submitted to the Undersecretary for Research and Development for approval and to the DOST-EXECOM for confirmation.


